

Pursuant to Article 44 paragraph 2 item 3 of the Central Bank of Montenegro Law (OGM 40/10, 6/13, 70/17, 125/23) and Article 33b paragraph (2) of the Law on Resolution of Credit Institutions (OGM 72/19, 8/21, 113/24), the Council of the Central Bank of Montenegro, at its meeting held on 5 February 2026, passed the following

## **DECISION**

### **AMENDING THE DECISION ON REPORTING TO THE CENTRAL BANK OF MONTENEGRO FOR THE PURPOSE OF PURSUING RESOLUTION FUNCTION**

#### **Article 1**

In the Decision Amending the Decision on Reporting to the Central Bank of Montenegro for the Purpose of Pursuing Resolution Function (OGM 40/25), in the Annex to the Decision in the S-PTZ Template, the heading of the column 10 shall be amended to read:

“Contractual liability under Article 47 paragraph (1) items 16) to 18) and Article 61 paragraph (1) items 13) to 15) of the Decision on Capital Adequacy”.

#### **Article 2**

This Decision shall enter into force on the eighth day following that of its publication in the Official Gazette of Montenegro.
